

Dear Colleagues,

This has led to further tightening of budgets which challenges our ability to travel and attend conferences. However, as a resourceful group, it was pleasing to meet online in 2023 (thank you again to our node leads; Stanley Chan, Nina Dickerhof, Paul Witting, Liz Ledgerwood and Peter Sly) for giving your time to make our science accessible to the community.



As this is my last year as the SFRR(A) President, it's been an absolute pleasure to work along-side inspirational colleagues Louisa Ashby (whose 4 year term as Secretary is coming to an end), Nina Dickerhof (stepping into the President's role), Stanley Chan (who stayed on as Treasurer ex officio), Balal Chami (who joined as Treasurer) and Natasha Vassileff (Early Career Representative). We've met monthly and always had a full agenda of discussions and decision making to complete (with a few laughs!). This year, we've finalised our move to a new bank, allowing the Society to complete all transactions online (previous transactions had to be completed in-person - very challenging with Executive members in different cities and states!). With this new banking system in place, we will see easier ways to pay our registration fees in future, making membership more accessible for all. Secondly, we've continued to support our early career researchers in their attendance of national and international conferences, so that they can share their science and gain valuable presentation experience and networking opportunities. This support includes providing sponsorship of the upcoming SFRR(I) conference (hosted by SFRR(Europe)) in Galway, Ireland in 2025 (a must for Ed Sheeran and Free Radical fans alike) - we hope to see you there! This involved the arduous tasks of multiple and coordinated in-person banking trips to help bring this to a successful conclusion.

ECR Representative's Update

There was an excellent turnout at the 31st SFRRA online meeting held last December. Minutes from the 2023 Annual General Meeting

Minutes of the 2023 Annual General Meeting of the Society for Redox Research (Australasia)

Monday 11th Dec 2023 – meeting held via zoom during the SFRRA Research Symposium 2023 which was a hybrid event; five physical nodes across Australasia of members attending together in seminar rooms as well as individual zoom attendees.

Chair: Andrew Bulmer (President)

Minutes: Louisa Ashby (Secretary)

Other SFRRA Executive members present – Nina Dickerhof (President-elect), Stanley Chan (Treasurer), and Jereme Spiers (ECR rep). Apologies: none received.

Attendance details: **19 members present in nodes at the time of this meeting,** including exec members, **and up to 12 additional participants logged on individually via zoom.**

The split across the nodes was Christchurch (7)/ Sydney (7)/ Brisbane (2)/ Melbourne (2)/Dunedin (1).

AGM opened 2:58 pm (NZ time)

1. President's address

- Andrew Bulmer thanked Tony Kettle and the team of organisers for last year's meeting in Christchurch

- the joint SFRRA&J Conference 2022, it was a very successful in-person meeting.

- Andrew expressed thanks to Louisa and other exec members for the Newsletter 2023 recently distributed, and to the Node leaders and speakers for the Symposium we're enjoying today.

- Special appreciation goes to Stanley Chan and Jereme Spiers who are now completing their four year terms as Treasurer and the first ECR Rep, respectively. They have worked hard and been excellent committee members – they have earnestly served the Society well.

2. Elections of new executive officers

- Andrew invited the self-nominated candidates to introduce themselves briefly in advance of voting:

- Dr Belal Chami candidate for role as Treasurer, member of SFRRA since 2015 as a student, now a group leader at Uni. Sydney. Keen to get involved and support the Society.
- Dr Natasha Vassileff standing for ECR Representative position, a new SFRRA member, working in redox field for last 3 years, is at ANU Canberra. Already involved in the carbon offset initiative.

• Dr Pramod Subedi – standing for ECR Rep. Unable to attend today's symposium, he provided a video recording that was viewed by all. He studied in the redox field for his Masters and PhD, and is now continuing at La Trobe Uni, Melbourne. Motivated to nominate after attending SFRRA&J 22 in NZ. <u>RESULTS</u>: via Slido.com voting app on attendees' mobile phones:

Treasurer – Belal Chami appointed (sole candidate, unopposed in Slido.com test vote, n=20 votes) **ECR Rep – Natasha Vassileff** appointed (86% votes, Pramod Subedi 14% votes, n=21 votes via Slido) Thank you to all nominees, congratulations and welcome to Belal and Natasha.

-Extra vote undertaken by members: Appointment of Stanley Chan as additional Proxy Treasurer (for 2024 only) in order to facilitate the closure of the current account (Commonwealth Bank), in relation to setting up new e-banking facility in Australia for SFRRA.

Results via Slido - In favour: 95%, Against: 5% (n=20 votes) Carried.

3. Treasurer's report 2022-2023

- Powerpoint slides presented by Stanley Chan: Current financial membership is estimated at 60 full members and 35 student members. At our first in-person conference since Sydney 2019, last year in

Christchurch (91 delegates) there were 68 SFRRA registrations and membership fees collected. The majority of other attendees were members of SFRR-Japan.

- Expenditure from the Australian account during 2023 totalled AUD\$10.3K, a large proportion of which was the award of six ECR travel awards of AUD\$750 for SFRRA&J 2022 in Christchurch, and dues to SFRRI for membership and sponsorship (AUD\$3.8K) of the conference in Uruguay. The major income to SFRRA remains the continued sponsorship arrangement with Taylor&Francis publishers (T&F) which annually provides approx. AUD\$3.6K net (varies depending on exchange rate). Payment to bring this up to date is in progress, due to arrive in the account imminently. The 21/11/2023 closing balance in Australia is AUD\$56.6K, AUD \$42.2K of which is on Term Deposit.

- The New Zealand account closing balance 24/11/23 NZD\$4.4K incorporates major items of NZD\$2.9K SFRRA membership fees collected at the 2022 conference, overall NZD\$309 conference profit, and expenditure items of ECR travel awards NZD\$3.6K and Poster prizes NZD\$500.

- Treasurer's report was opened for discussion: Liz Ledgerwood commented that it would be good to see anticipated outlay for Travel Awards included in the upcoming year's budget. Also it would be worth considering the security of the T&F arrangement going forward, ie: can this be expected to continue? it is relied on for the stable status of the SFRRA finances. Christine Winterbourn queried how the money transfer from T&F works - answer; it is by deposit of GBP and return payment of AUD.

- Andrew Bulmer added that it is worth noting that there are increases in the costs of our insurance (previously \$600 now \$945) as well as travel costs (affecting value of travel awards) so it would be good to ensure term deposit interest is optimised (considering direct access account options when internet banking is established), as well as thinking of possible new ideas around useful increases in sponsorship income (maybe new industry partners). Stanley Chan added that maybe non-conference (in-person) years could provide good periods to benefit from term deposits with better rates.

4. ECR Representative's report

- Jereme Spiers congratulated all Early Career Researchers who were recipients of the various awards made available this year. There were several young investigator awards (for presentations – from SfRBM and T&F) in addition to the travel awards (SFRRA and SFRRI) that help ECR attend those conferences. We (SFRRA) also provided support of related research societies – the Australia and New Zealand Societies for Biochemistry and Molecular Biology (ECR poster prizes).

- Jereme described being inspired by the Tree-Planting charity carbon offset surcharge of the SFRRA&J 2022 conference to seek out ongoing funding support for similar environmental initiatives in Australia before our next in-person meeting. He has applied to three funders (Murphy initiative and Future Earth Australia, both run through Australian Academy of Science, and a third independent one) and is waiting to hear soon if successful. He expressed congratulations to Natasha and Belal on their appointment to the exec committee, and gratitude to SFRRA for his term as the first ECR Rep.

5. Other Business

- Andrew Bulmer announced that the drawn-out name change process for SFRRA (Society for Redox Research Australasia) is now formally complete, confirmatory paperwork received from the Fairtrade register, although their online listing still needs to be updated. Special thanks go to Paul Witting for acting as proxy listing officer resident in NSW. The initial concept of a name change to better reflect the society's research scope was made in 2018, so it has been a long road.

- Andrew reported that two of our members were put forward as nominees for the Trevor Slater and Lester Packer awards made at the recent SFRRI conference in Uruguay. Unfortunately our SFRRA nominations were not successful, and he had noted the need to provide stronger applications to be competitive in future (every two years) as other societies had included multiple-signatory letters of support etc.

- Andrew wanted to inform that the executive committee is interested in new ways to improve SFRRA's international engagement and global visibility in science. Current ideas include SFRRA expert

presentations to be shared online, and possibly an advisory group that could help with recommendations for increasing global involvement.

- Liz Ledgerwood said she was pleased to represent our society at the SFRRI conference in Uruguay, and attended their executive meeting on behalf of SFRRA. She has calculated that on a per capita basis, we actually have a strong society for a relatively small region, with high membership rates compared to the larger societies in Europe and USA, for example. The Europe society (SFRRE) has introduced regular shared seminars, but she doesn't know how well these are attended in terms of the percentage of members. For initiating something similar, we should remember we have smaller numbers and comparatively our institutes and universities are under higher financial strain. We rely on volunteers whereas the US society can afford to pay a company to organise events, so if we can make links with their existing activities that might be worthwhile.

- Judy de Haan, president of the Australian Atherosclerosis Society (AAS), said they run a virtual seminar series that is well attended. This started during the Covid pandemic and has been successful for three years. Maybe SFRRA could consider doing something similar quarterly, especially to strengthen the connection across the Tasman.

6. Plans for SFRRA in-person conference - venue/hosts for 2024

- There have been two expressions of interest about possible Australian host cities.

- Jereme Spiers shared two slides proposing the ANU campus conference venue in Canberra as possible host for SFRRA conference in Nov/Dec 2024. It would be first time our conference was held in Canberra, excellent university facility with 300-seat tiered theatre, maybe residential colleges for accommodation. Direct flights for domestic travellers, internationals would come via Sydney airport then maybe transfer bus. Venue is a 15 walk from city centre.

- Judy de Haan showed a slide about a venue she used for the AAS conference last year – The Monash Conference Centre in the CBD of Melbourne. It has two large rooms; one holds up to 80 and the other about 50, plus an additional small meeting room.

- Christine Winterbourn wondered if the Melbourne venue might be too small especially considering the need for space to display posters.

- Nina Dickerhof enquired about the organising team for each suggested city. Judy said due to her AAS commitments she could offer some help but not be lead organiser in Melbourne.
